Coerced to undergo a tubectomy, lost her childhood, education, reproductive rights and future prospects. Presently living in Yaoundé as Mr. Danpullo's wife but for how long?
Balkisu Yahuba	14 years old	Forced out of school and forced to marry Mr. Dapullo (her father was imprisoned by Mr. Danpullo). She travelled abroad to get away from Mr. Danpullo who engaged legal action against the father of her suspected benefactor. She underwent mental torment and lost an opportunity to complete her education thereby damaging her future prospects.
Hurera Umaru	13 years old	Forced out of school but has never lived with Mr. Danpullo; have no children. Lost her childhood and education, not able to marry or gain employment even though Mr. Danpullo has abandoned her. Still living in her late father's home in Wum.
Kursi Ibrahim	14 years old	Forced out of school but the marriage did not last - was forced to live in her brother's home by Mr. Danpullo for over 15 years. Umaru Kombo, Wakilu Kombo, Elh. Souley Moussa and Ousman Haman have been persecuted for their connections to Kursi. Presently in Cameroon.
Berebi Hammeh	18 years old	Seized from her husband Isa Wakilu to become a mistress to Mr. Danpullo for many years and abandoned her and later arranged for her to marry his relative. Presently in Cameroon.
Halima Hassan	12 years old	Had two children with Mr. Danpullo and then he abandoned her. Not able to

		re-marry due to history with Mr. Danpullo and no gainful employment. Presently in Douala.
Jeinabu Manga	15 years old	Seized from husband Yaya Anugu and then abandoned not long after. Suffering from history with Mr. Danpullo. Presently in Cameroon.

ARBITRARY AND UNILATERAL DISSOLUTION OF MBORORO ORGANISATIONS

The North-West Cattle Breeders Cooperative Society was set up in 1982 by Mbororo herders. Baba Ahmadou Danpullo dissolved the Cooperative which had 129 members, who each held shares of 50,000FCFA plus cattle and he seized its ranch of 83 cows and liquid cash of over 4 million and imprisoned its leaders.

He verbally dissolved MBOSCUA in 1993, but he has not succeeded in effectively getting it disbanded and has resorted to sabotage and persecution of its members and the creation of SODELCO and Ardos Union.

ABDUCTION, VIOLENT ASSAULT AND TORTURE BY ARMED MILITIAS

1. Musa Bureh, Sabga - shot with a gun in the neck in Sabga on Mr. Danpullo's orders.

2. Hamadu Bello Buba, Fundong - tortured and illegally detained in Ndawara on Mr. Danpullo's orders!
3. Abdu Joda, Ndop - Abducted, beaten up and abandoned in a forest by Mr. Danpullo's thugs.
4. Fadimatou Dahirou, Yaounde - attacked at home in Yaoundé and abused following warnings.
5. Rahmatu Adamu, UK – attacked in her home in Bambui by Mr. Danpullo's agents.
